#### 8. SALES TAX and OTHER GOVT DUTIES

- i. #### 9. SECURITY

As per RFP, The contractor has deposited performance security (10 % of the total Contract Amount) in shape of bank guarantee vide No.0018/BAH/1109/2021 Dated: May, 19, 2021 amounting to Rs. 3,443,999/issued by Bank Al-Habib Ltd. PECO Road Branch Lahore in favour of CEO, PITC. This performance security shall be payable to PITC in case, if bidder fails to fulfil the obligations under the contract or violates any of the terms and conditions of the contract.

The vendor will have to submit Performance Guarantee/Security i.e. 10 % of the value of each Work Order in addition to the quantity mentioned in this Rate Contract in the name of the Consignee who issues the Work Order.

The contractor's bid security shall be discharged upon signing the rate contract, furnishing performance/ bank guarantee and confirmation of performance/bank guarantee by PITC from the Bank of the contractor and the same shall be released after expiry of contract.

### 10. FAILURE AND TERMINATION

i. If you fail to complete work (including installation & commissioning) within the specified period, indenter/consignee shall be entitled to the following actions

a. In case of late, penalties at the following rates will be applied:

### Mode of Penalty

With penalty @ 0.5% of the value of the Services, supplied beyond stipulated delivery schedule for each week or part thereof of delay until actual performance, subject to a maximum of 10% of value of such services.

- ii. If during the course of execution of this contract, your firm is black listed, the department may proceed with all or any of the action detailed below;
  - a. To allow the contractor to complete the contract in accordance with the terms & conditions of contract
  - b. To stop further services with or without financial repercussions
  - c. To cancel the contract with or without reservation of rights.

#### 11. FORCE MAJEURE

While terminating the contract for breach of contract or imposing liquidated damages, the consignee shall give due consideration to the circumstances leading to the breach of contract or delay on which you had no hold, examples of which are;

- i. Act of State, Enemy or God Almighty
- ii. Lockout, strikes
- iii. Restrictions imposed by the government in the matter of import/export
- iv. Injunction granted by a lawful court restraining you from executing the contract unless such injunction was due to any alleged irregularity committed by you

While determining liquidated damages the consignee shall not consider any of the following circumstances, a clause under "Force Majeure" and shall not allow any relaxation in the liquidated damages on that account.

- i. Delay on the part of contractor in the arrangement of raw materials
- ii. Defect or failure occurring to any machinery or equipment installed at the contractor works during the currency of the contract.

#### 12. PAYMENT
