### 2. Instructions To Bidders

- ii. **Bid Closing Date & Time:** 24 June 2026 at 11:00 AM.
- iii. **Bid Opening Date & Time:** 24 June 2026 at 11:30 AM.
- iv. The quoted price must be firm, final, inclusive of all taxes, transportation charges etc. And should be in Pak Rupees.
- v. PITC reserves the right to accept or reject any or all bids as per company disposal procedures and WAPDA/PEPCO rules.
- vi. Bid offered is likely to be ignored if: -
  - a. The tender document is unsigned (all pages should be signed).
  - b. It is received after the time and date fixed for its receipt.
  - c. Offer is ambiguous or conditional.
  - d. The offer is from a firm who is blacklisted by PEPCO, PITC, NTDC, WAPDA or any other government organization, or is in litigation with any government organization or is defaulter in any previous order and/or contract.
  - e. The offer is unsolicited.

#### 4. Award and Payment

- i. The successful bidder shall be required to deposit 25% of the bid amount in form of CDR as earnest money on the spot.
- ii. The remaining 75% of the bid amount must be deposited within 10 working days of the approval.
- iii. Applicable Government taxes (GST/Income Tax) will be charged in addition to the bid amount as per prevailing laws.

#### 5. General Conditions of the Contract

- i. **Disclaimer of Liability:** The Procuring Agency disclaims all liability after the sale regarding the future use, safety, or any impact of the disposed assets.
- ii. **Asset Removal:**
  - a. Assets must be lifted within **10 working days** of the Release Order.
  - b. Failure to remove items within the deadline shall attract a storage charge (ground rent) of 1% per day of the total bid value.
- iii. **Labour and Logistics:** The bidder is solely responsible for all labour, loading, and transportation arrangements.

#### 6. Grievance Redressal

Any bidder feeling aggrieved by any act of the Procuring Agency may lodge a written complaint with the Grievance Redressal within seven (7) days of the announcement of the evaluation report.
